Appendix C - President's Annual Report

Mowbray Public School P&C promotes the interests of and supports the development and further improvement of Mowbray Public School for all students, teachers, staff members, and our local community. In 2023, I am pleased to say that we lived up to our association goals.

In 2023 we continued to work closely with our Principal Caroline Alford, to ensure that the P&C are working in alignment for the benefit of the students and wider school community. Mowbray P&C was able to contribute an additional \$50,000 in 2023 towards new play spaces in the school - bringing our contribution towards this project to \$100,000.

We were able to achieve our fundraising targets through the generous voluntary contributions of our Mowbray families and some great fundraising events including the Colour Explosion and Tropicana event. Thanks to the support of Lane Cove local businesses and Mowbray families who donated raffle, auction and event prizes. Thanks also to the classroom teachers and students at Mowbray who made our amazing Class Art which was auctioned.

The Music Program continued to flourish in 2023, being the first year of a true "one program" subcommittee. Thanks to the Music subcommittee and our Band and Strings Conductors for their efforts in 2023. Our Strings and Band ensembles participated in and achieved recognition in a number of competitions and performances throughout the year and interest in the program increased at the end of year recruitment.

There were a number of P&C initiatives that were implemented in 2023 which have made a substantial improvement to the operations of the P&C and our engagement with the community. Thanks to Daniella Kucic and Amy Tang for their work on engaging a bookkeeper and auditor. This has improved our processes for both the P&C Treasurer and Music Subcommittee Treasurer. We created a separate group for the Class Parents community, providing "ready to go" communications and a support network for Class Parents. This has improved engagement and seen an uplift in participation in 2024. We also started on the P&C website refresh, which has just been completed. Thanks to Pat Torres for her assistance with this project.

Our biggest challenge for 2023 was volunteer participation. We were able to continue all events and canteen operations but it took many requests to get volunteers, and in some instances it was the efforts of the P&C Executive Committee and some dedicated volunteers who filled in the gaps on the day. We have experimented with some measures to reduce the volunteer requirement in 2024 without sacrificing events and operations - the canteen is currently being staffed by Sweet Temptations staff 3 days a week and we

are consolidating Mother's Day and Father's Day to one event (Parents and Carers Morning Tea). Hopefully we can improve volunteer participation as the school grows.

The outgoing P&C Executive leaves the association in a very strong position from both a financial and operational perspective. I am sure that I speak for all of us when I say that we have been proud to serve the Mowbray school community.

As this is my final year as P&C President, I would like to thank the outgoing P&C Executive team - Vice Presidents Di DeBelin and Cristina Villamayor, Secretary Amy Harbin, Treasurer Amy Tang and Executive members Angela Sharpe, Eddie Stanton-Cooke, Music Convenor Daniella Kucic, Online Lead Pat Torres and Events Leads Courtney Wong and Gemma Starzec-Conti. It's been a great experience to work with you and you should be proud of what we achieved together in 2023. Thanks also to the ongoing support from the school - Principal Caroline Alford, Deputy Mandy Ryan, General Assistant Alan Brown, the team in the office and teaching staff. Finally thank you to all our P&C members and Mowbray families for continuing to support Mowbray P&C.
